Diesel Prices Hit 2019 High Mark

The national average price for diesel fuel hit a new high for 2019 during the most recent week, rising by a penny to \$3.08, according to the Department of Energy's weekly report.

The year's previous high was \$3.079 earlier this month, however, this week's national average is the highest since the week ending Dec. 17, when the country's average price was \$3.121 per gallon.

Fuel prices increased in all but one region during the most recent week with the most significant increase being seen in California, where prices jumped by 3.8 cents. The Central Atlantic region was the only region to see a decrease during the week, which was just three-tenths of a cent.

California remains the most expensive at \$3.819 per gallon, followed by the Central Atlantic region at \$3.31 per gallon. The cheapest fuel is in the Gulf Coast region at \$2.876 per gallon, followed by the Rocky Mountain region at \$2.974 per gallon.

Prices in other regions, according to DOE, are:

- New England \$3.214
- Lower Atlantic \$2.995
- Midwest \$2.993
- West Coast less California \$3.156

ProMiles numbers during the same week saw fuel prices increase by two-tenths of a cent to \$2.991 per gallon.

According to <u>ProMiles Fuel Surcharge Index</u>, the most expensive diesel can be found in California at \$3.698 per gallon, and the cheapest can be found in the Gulf Coast region at \$2.873 per gallon.

So much unnecessary fuel is burned every day from long idling times. To put this in perspective, there are many gallons of fuel wasted each month, and this translates into lost dollars. Thank you for your efforts in watching idle times, as fuel costs continue to increase.

Lead Shop Mechanic in Plover, David Ryskiewicz Receives Award

Sheriff Mike Lukas recently presented two Life Saving Awards at a small ceremony held at the Law Enforcement Center. (Portage County Boosters) Deputy Florian Chojnacki and citizen David Ryskiewicz were recognized for their actions at the scene of a medical emergency earlier this year. Mr. Ryskiewicz's co-worker collapsed at their place of employement. 911 was called and Mr. Ryskiewicz immediately administered CPR. Deputy Florian Chojnacki arrived and deployed an automated external defibrilator (AED). Several shocks were delivered before additional EMS responders arrived. The victim was conscious and alert before being transported to the hospital. The decisive actions of both Deputy Chojnacki and Mr. Ryskiewicz directly lead to the victim's recovery from a life-threatening medical emergency. Their actions reflect the highest of credit upon themselves, their employers, and the entire community.

Safety Vest Compliance

Federal Highway Administration (FHWA) by law requires vests when the road is a federal aid highway. Also noted by Osha that any situation where a driver would be in a traffic area, which would include parking lots.

Some shippers require that drivers wear vests even when trucks are being loaded or unloaded. So, with that, for personal safety, drivers should be wearing their vests.

That would include: while fueling, while adjusting tandems, any situation where the driver would be out of their truck and attending to maintenance, sweeping out trailers, walkarounds for pre-trip, post trips, in traffic on roadways, etc. As good practice, potential liability, and for your safety, it is important to wear them.

- Wear your vest today to keep the DOT away. It signifies that we as a company and as employees are adhering to regulations and are in compliance with industry requirements.
- Wearing your vest increases visibility on the job and at night.
- Some shippers require vests when on their property. This signals to the customer that Terminal Transport drivers are professionals and take pride in their work and put safety first.

Safety Tips for Roadside Breakdowns



You're heading down the highway when trouble strikes. Whether it's a flat tire, a dying battery or an electrical issue, you'll need to know how to react. Use these tips to stay safe during a roadside breakdown:

Find a safe place to pull over. If your truck is still drivable, pull over on the side of the road, as far away from traffic as possible. Try to avoid areas where visibility may be bad, such as tight curves or a hillside.

Turn on your four-way flashers. If it's at night, also keep your headlights on and turn on the dome light in the truck.

Put on your high-visibility safety vest. If your truck doesn't have one, you should get one. They are bright lime or yellow, with reflective striping that ensures you are seen even on the darkest roadways.

Set up your truck's warning devices. All trucks must carry warning markers. Typically, you'll find three reflective triangles, but your vehicle may also have fuses or liquid-burning flames. The Federal Motor Carrier Safety Administration's (FMCSA) regulation 392.22 requires drivers to place warning devices outside their truck within 10 minutes of a highway breakdown. Per the regulation:

Place the first warning device on the traffic side of and about 10 feet (four paces) from your stopped truck in the direction of approaching traffic.

Place a second device about 100 feet (40 paces) from your stopped vehicle in the center of the traffic lane or shoulder occupied by your truck and in the direction of approaching traffic.

Place a third device about 100 feet (40 paces) from your stopped vehicle in the center of the traffic lane or shoulder occupied by your truck and in the direction away from approaching traffic.

On a divided highway or one-way road, place the first warning device at 200 feet and the second at 100 feet in the direction toward approaching traffic in the center of the traffic lane or shoulder occupied by your truck. Place the third marker within 10 feet of the rear of your truck.

If your truck breaks down on a curve or in an obstructed area, place warning signals 100 feet to 500 feet from your truck. Warning devices are required in a business or residential district only at night. Return to your truck and stay inside. Call for service (Penske Truck Leasing offers 24/7 roadside assistance) and notify your dispatcher. Do not try to fix the truck yourself. Remain in the cab until help arrives.


