ELD Compliance In Effect 2019

The primary focus of ELDs is to ensure drivers are complying with federal drive-time regulations, but carriers can use the data and the devices to monitor engine hours, miles driven and location information. That information can help companies identify inefficiencies, negotiate with shippers and manage delays. They can also use the information to provide customers with a load's estimated time of arrival so they can schedule labor.

Information coming off the engine and ELDs can also help fleets identify and analyze driver events, such as hard braking. Fleets can use the information to coach drivers and improve driver safety.

The ELD Rule is intended to help create a safer work environment for drivers, and make it easier and faster to accurately track, manage, and share records of duty status (RODS) data. An ELD synchronizes with a vehicle engine to automatically record driving time, for easier, more accurate hours of service (HOS) recording.

The ELD final rule does not change any of the basic hours-of-service rules or exceptions. We appreciate everyone's cooperation in transitioning to the new ELD regulations and learning the new systems.

Drug & Alcohol Clearinghouse Effective Jan. 2020

We are weeks away from the Clearinghouse going into effect. Many drivers are unaware of the requirement that they must register within the Clearinghouse should they wish to change jobs any time after Jan. 6. There's still a huge learning curve right now, both in terms of knowing that registration is a requirement for driver job seekers and how to register within the system.

The rule establishes a database of drivers who've failed or refused a drug test, and fleets of all sizes will be required to query the database for all new driver hires and yearly for existing drivers. Fleets will also be required to upload results of failed drug tests to the Clearinghouse. Also included in the database will be information on drivers who've been cited for violating alcohol laws specific to trucking. There also will be information on whether a driver has completed the return-to-duty process after a positive drug test or alcohol violation.

Registering in the Clearinghouse is required for when a driver wishes to change jobs and when a fleet first hires a driver after the rule becomes effective, (1/06/2020) and for yearly review of existing drivers. Terminal drivers will receive more information for how to register. Thank you for adhering to the new ELD & Clearinghouse Rules.

DRIVER UPDATES WINTER GEAR

Winter is here! I know this appeared in the last newsletter but it never hurts to remind people of the fury of Mother Nature in this area, particularly in that we have a few new drivers from south of the Mason Dixon Line! Make sure you have an extra blanket, warm boots (time to put away the flip flops), warm coat, gloves and stocking hat. A heating pad in the bunk turned on about 30 minutes can keep blankets warm for a period of time without running the truck. Make sure your flashlight has new batteries. A can with sand in it with a small candle can come in very handy as well to heat the cab if stranded or can help with traction. To help keep the trucks running at the proper temps, if it has a winter front, put it on. We also have Power Service at Roseville & Plover. You know what you may need personally so be prepared. If anyone has some other helpful tips for winter survival, pass them on to Tammy.

Winter Driving Kit Essentials:

Keep your Winter Driving Kit close by and stock it with:



- Proper clothing (loose layers, extra gloves, winter coat, boots, warm socks)
- A flashlight and batteries
- A blanket
- Non-perishable food and water
- A First Aid kit and any required prescription medication
- A bag of sand or salt
- Extra washer fluid
- A windshield scraper and brush for snow removal
- Jumper cables
- Cell phone and charger

Cab Filter Maintenance

Why is it important to change the cabin air filters?

The trucks have at least 3 cab air filters: fresh air from outside, recirculated cab air, and bunk heater. It is important to be aware of where they are, as it affects the air quality you are breathing. Just like a home furnace filter, they need to be changed regularly. The more plugged, the less air flow and harder the system has to work. If the Defroster is slow, or truck too cold in winter or too hot in summer and your fan is always on the highest setting? It is the first item to check. Air flow loss could be the culprit. Last week, Dave changed a filter that was black on both sides. It was so plugged, the HVAC system started to suck the entire filter from the housing into the duct, and pulling as hard as Dave had to, the filter came apart. It looked like an accordion once it was out. We felt bad for the driver, as they were not even aware of it. Breathing poor quality air can make you sick - if not most of the time if you suffer from allergies. How can all of you help? It's simple - have an idea of when it was changed last. We keep track of this, but many factors affect how long the filers last. We want you to be safe and healthy!
