Road Check Inspection Blitz Set For Early May

In January the Commercial Vehicle Safety Alliance (CVSA) announced that the annual International Road Check - 72-hour inspection blitz, will be held May $5^{th} - 7^{th}$ this year.

Federal Motor Carrier Safety Administration (FMCSA) data shows that in 2019, 3.36 million CMV inspections were conducted and during these inspections, 944,794 driver violations were discovered, of which 195,545 were out-of-service conditions.

During Road check, most drivers will undergo the North American Standard Level I Inspection. Level I inspections are the most thorough, including examination of both driver compliance and vehicle-related violations. The vehicle inspection includes checking critical vehicle inspection items such as: brake systems, cargo securement, coupling devices, driveline/driveshaft components, driver's seat (missing), exhaust systems, frames, fuel systems, lighting devices, steering mechanisms, suspensions, tires, van and open-top trailer bodies, wheels, rims and hubs, and windshield wipers. Drivers will also be required to provide their CDLs, Medical Examiner's Certificates, logs and more. If no violations are found, inspectors will issue a CVSA decal that indicates the vehicle has passed an inspection.

The CVSA describes International Road Check as "the largest targeted enforcement program on commercial motor vehicles in the world, with around 17 trucks and buses inspected, on average, every minute in Canada, the United States and Mexico during a 72-hour period."

Contact dispatch if you have maintenance issues that need to be addressed. Make sure you are doing your **Pre/Post Trip Inspections**. Issues addressed in a timely manner, can help avoid a more serious maintenance issue in the future. Operating safe equipment, also keeps (you) the driver safe.

SCHEDULING VACATIONS & APPOINTMENTS

We have a lot of new drivers and would like to remind everyone new and old that we would appreciate this coming year, if you have Doctor/Dentist appt, family reunion, anniversary or special time you need to be off, please take your vacation around that time so we minimize the number of drivers off and do not jeopardize our customers operations. We have many drivers that put in for vacation at a certain time and we try to accommodate everyone's schedule but can't have 30% of our drivers off. So, when vacations are approved and then people come in needing additional time off for the above, it is difficult to manage our business. We will be looking a little harder at that going forward. So, my advice, plan ahead. This is also a reminder that when looking into 2020 if there is a conflict in vacations with other drivers, seniority will take precedence. The earlier you can plan the more efficient we can plan our schedules. We appreciate everyone's cooperation in this matter.

COST REDUCTION

2019 was a challenging year in transportation. The economy slowed due to trade barriers and manufacturing cycles. GDP is expected to grow about 2%. However, that is less than the 3% that was sustained in 2018. Equipment costs have risen due to the increase in commodity prices such as steel, rubber, aluminum and copper. We expect 2020 to be no different in terms of the challenges that we face in reducing costs and improving efficiencies. We will be minimizing any capital expenditures this year due to the increasing costs of new equipment. However, we will be looking to improve efficiencies by increasing our expenditures on products that will lower our fuel costs.

We have partnered with "Flow Below" to help lower our carbon foot print and reduce fuel consumption by installing their products on our trailers. This project will begin in late February and early March. It will continue through the year to install their fuel reducing products on all our trailers through 2020 and beyond. The UT6 which we have on many trailers has been discontinued when purchased by EkoStinger. We will begin replacing their units on the trailers also beginning in March. Most installation of the Flow-Below products will take place in Plover, WI. The EkoStinger is a product sold through Trudell Trailers and will be installed in Albertville or in Green Bay, WI. Our goal is to improve our fuel efficiency by 10% in 2020. To accomplish this, we are looking for help from our driver associates to further reduce the idle times and overspeed issues. To eliminate the overspeed's, please use your cruise controls whenever possible.

Fueling

As everyone is aware, The Pilot is our fuel stop of choice. I am requesting that drivers use the Kwik Trip stations as their second choice. Primary fuel suppliers should be the PILOT/ FLYING J. I will be monitoring the purchases in the next several months to make sure everyone is doing their best to use the Pilot. I appreciate your cooperation.




FMCSA Drug and Alcohol Clearinghouse – Effective 1/6/2020
