

banning truck parking on urban streets. As of 2019, the MN budget did not give the MN DOT any funding specifically designated to truck parking. As I am finishing the Newsletter, the MN legislature is just finishing the budget which has grown considerably (which I may comment on later) from 35 Billion to over 50 Billion in the last 5 years, with very little if any for truck parking. MTA and the NATSO are working with the current legislature to improve and expand truck parking in the state which has become a premium. Most likely any budget issues coming from the state legislature won't happen until July as both parties are extremely distant from any compromise.

# **NEW EQUIPMENT**

As of July 2, we have all the new trailers manufactured in Kewanee completed. They are now in the process of going through quality control at the Great Dane Trailer Plant for final inspections and are simultaneously being decaled by TKO Graphics on the plant site. We are still working out the logistics of moving the trailers into Plover to complete or moving some up to the Twin Cities to be completed or then loaded towards Plover for completion. Our preferences would be to get them to Plover for completion and then get them into service from there. We have 15 trailers we are trading of which 10 will be turned into Albertville, MN and the other 5 into the Plover terminal for Trudell trailers to pick up. We hope to start seeing them in service by August.

We also have 7 new Freightliners due in by the 1<sup>st</sup> part of August. Some of these will be replacing the 2018 T680 KW we have had along with adding some additional power to our fleet. We still have several new Penske trucks we are looking to fill so if you have any friends or neighbors looking for a job, we are hiring!!! ### motor vehicle (CMV) as a personal conveyance?

A driver may record time operating a CMV for personal conveyance (i.e., for personal use or reasons) as off-duty only when the driver is relieved from work and all responsibility for performing work by the motor carrier. The

CMV may be used for personal conveyance even if it is laden, since the load is not being transported for the commercial benefit of the carrier at that time. Personal conveyance does not reduce a driver's or motor carrier's responsibility to operate a CMV safely. Motor carriers can establish personal conveyance limitations either within the scope of, or more restrictive than, this guidance, such as banning use of a CMV for personal conveyance purposes, imposing a distance limitation on personal conveyance, or prohibiting personal conveyance while the CMV is laden.

#### A relevant example of appropriate use of PC

Time spent traveling to a nearby, reasonable, safe location to obtain required rest after loading or unloading. The time driving under personal conveyance must allow the driver adequate time to obtain the required rest in accordance with minimum off-duty periods under 49 CFR 395.3(a)(1) (property-carrying vehicles) or 395.5(a) (passenger-carrying vehicles) before returning to on-duty driving, and the resting location must be the first such location reasonably available.

#### Examples that do NOT qualify to use PC

- The movement of a CMV in order to enhance the operational readiness of a motor carrier. For example, bypassing available resting locations in order to get closer to the next loading or unloading point or other scheduled motor carrier destination.
- Continuation of a CMV trip in interstate commerce in order to fulfill a business purpose, including bobtailing or operating with an empty trailer in order to retrieve another load or repositioning a CMV (tractor or trailer) at the direction of the motor carrier.
- Time spent transporting a CMV to a facility to have vehicle maintenance performed.
- Time spent traveling to a motor carrier's terminal after loading or unloading from a shipper or a receiver."

#### Summary:

PC is a tool to help you. Don't abuse it. Terminal has a 40-mile limit on PC. If you use it, you must notate it in your logs and when you certify that log you are putting your signature on a legal document.

PC violations have a huge impact to conducting business. They impact Terminals CSA score, insurance rates, PrePass, inspection selection score etc. Too many violations can trigger an audit and fines for carriers. Additionally, drivers may face citations and fines for violating PC laws. We hire professional drivers and expect the laws are followed. Zero log violations in a month earns you an extra \$50 on your safety bonus!
