

ROADBLITZ RECAP

As we start the second half of our Fiscal year, we need to pay closer attention to our Safer scores. These scores are determined by the inspections that our equipment receives at the state scales. Over the past several weeks we have had 7 inspections that have shown no violations, which is excellent, and I would like to thank those drivers for their efforts. However, we have had several issues in the past several months that will cause our scores to increase. These incidents, either positive or negative, impact our scores. These scores are like diesel fuel prices, quick to move up and slow to move down!

Several of these categories look critical, but the smallest violation will drive these scores up. An example being, if you are not wearing your seat belt, this will give us a violation of "unsafe driving". Is this unsafe driving? According to the DOT it is and can cause our scores to elevate to a height that will then mandate that the scales inspect all our equipment. Once you are on the scale, the inspectors are free to inspect anything and everything. A new truck, trailer and driver have over 5000 combinations that can be inspected so most likely if they want to find something, the inspector can. The best remedy is to avoid this situation, so do what you're supposed to do on your pre-trips and look for any defects that may negatively impact this score.

Another category is "Controlled Substances". Many states are passing laws to allow various controlled substances to become legal. These are state passed laws and are not Federal. Using a controlled substance violates Federal Laws and is therefore illegal for OTR Drivers. Any use will result in immediate termination. These violations are of a serious nature and will stay on our Safer score for over a year. If you have questions about any of the categories, please give David a call to discuss. We would much rather discuss these categories internally with you than with an inspector on a scale. Thank you for your cooperation.

TIRES

Drivers should be inspecting their steer tires every day as part of their pre-trip. We are seeing wear on the inside of the tires that are not being picked up on the daily inspections because the drivers are not turning their steer tire fully to the left or right to expose the

inside of the tire! By turning the tires all the way right or left you expose the face of the tire, exposing the whole tire's face! This will help you recognize uncommon wear on the inside of the tire, alerting dispatch of a potential tire failure. It is important to catch this wear early to possible save the tire by getting it balanced or at least being able to move it to a trailer position to run, then cap the tire saving the casing. Running it into the cords ruins the tire and eliminates any casing use. These casings can be worth as much as \$200.00

MARIJUANA LEGALIZED MN

Minnesota recently joined the growing list of states legalizing recreational marijuana. This is a friendly reminder that Marijuana is still illegal federally, and commercial drivers are prohibited from using marijuana. A positive test for marijuana will still get you terminated and subject to a substance abuse program to get your driving privileges reinstated.

You should also be aware of products containing CBD. While CBD itself is legal, due to lax regulations, THC can often be found in CBD products, and testing positive for THC will also result in termination and require you to complete a substance abuse program to get your driving privileges reinstated.

BRAKE VIOLATIONS

Nearly 800 trucks were placed out of service during an unannounced CVSA initiative in April. Over one in ten vehicles that was inspected had a brake related critical inspection item indicating they were unsafe for the roadway. The top three violations were:

- 20% Brakes Violations 479. A vehicle or combination of vehicles is declared out of service when 20% or more of its service brakes have an out-of-service condition resulting in a defective brake, such as a brake out of adjustment, an audible air leak at the chamber, defective linings/pads, a missing brake where brakes are required, etc.
- Other Brake Violations 368. Examples of other out-of-service brake violations are worn brake lines, broken brake drums, inoperative tractor protection system, inoperative low air warning device, air leaks, hydraulic fluid leaks, etc.
- Steering Brake Violations 81. Examples of automatic standalone out-of-service steering axle brake violations are

inoperative brakes, mismatched brake chambers, mismatched slack adjuster length, defective linings, etc.

This was just a one day inspection. Be sure that you are inspecting your braking systems every day on every trip. We want to avoid citations, but more importantly, we want to keep you and the public safe!

DRIVER LICENSE RENEWALS

When renewing your CDL you should add a tanker endorsement. Some of you have this endorsement and it can be helpful when we are looking for reloads particularly in the fall as farm chemicals are moving. There is a small fee for this endorsement but there is no test required, fingerprinting, etc. This is also a reminder that when you renew your physical, you must tie this physical to your license through the respective state's that you have your drivers license in. It is very important that you complete this procedure with the state, or you are in violation.

DAMAGE ON THE ROADWAY

See below for images of damage to the one box on one of our trucks. This is another reminder of why we don't run at night any more than absolutely necessary. Something was hit on the roadway and it damaged the one box (part of the exhaust system). It's not repairable and is a \$9,000 replacement.

If you ever hit an obstruction on the roadway, make sure to report it and do a thorough inspection. Everything seemed fine until it started smoking.
