O Preplans and Managing Your Hours

Dispatch works hard to preplan your next load so you're not sitting empty, wasting hours. If you receive a preplan that won't work with your available hours, **let dispatch know right away**. We monitor your hours closely, but we rely on your input—especially when you're getting close to your 70. Letting us know early helps avoid a domino effect that can delay loads for other drivers too.

Your communication makes a big difference!

® Equipment Inspections Matter

Whenever you hook to a trailer, take the time to do a **thorough inspection**.

- Check that all tires are inflated properly (not over OR under) and not showing signs of chopping or wear.
- If something looks off, let us know before you hit the road.

d Clean Trailers = Professional Image

Please **don't leave trash behind** for the next driver. A clean trailer keeps things professional for our customers and respectful for each other.

Watch for Roof Damage at Consignees

Before leaving a customer's dock, look up! If you spot any damage to the trailer roof, **report it to dispatch before you roll out**. It's much easier to address issues when we know where and when they occurred.

1. Take the Hazmat Theory ELDT course

Required by FMCSA. Available online and self-paced. Some popular providers:

- o C1 Training
- ZETA Driving School
- Midwest Truck Driving School

2. Pass the TSA background check

Start at universalenroll.dhs.gov Cost is around \$86 and includes fingerprinting.

3. Take the Hazmat written test

Schedule with your local DMV or licensing office after your theory training is completed and your TSA background check is in progress.

Get Ready for CVSA Brake Safety Week!

Brake Safety Week is coming in August, and roadside inspectors will be paying extra attention to brake systems. Last year, brakes accounted for over 35% of out-of-service violations during this blitz - don't let that be vour truck!

What inspectors will check:

- Brake hoses and tubing no leaks, kinks, or wear
- Slack adjusters proper adjustment, no damage
- Air leaks listen for hissing, check connections
- Low air warning devices working as they should
- Brake linings/drums no cracks or contamination
- Parking brake functiona

★ What you can do now:

- Add brakes to every pre-trip and post-trip. A quick tug test and visual check go a long way.
- **Listen for leaks** when you set or release brakes.
- **Report issues immediately** don't assume someone else already has.
- Ask if you're unsure. If you're not 100% on how to check something, let us know we'll gladly review it with
