- Always inspect trailers when picking them up. If you spot damage, notify dispatch before heading out—not after.

# PC & Adverse Driving Conditions – Know the Rules

We've seen some confusion around **Personal Conveyance** (**PC**) and **Adverse Driving Conditions**, so here's a quick refresher to help keep things compliant:

### Nersonal Conveyance - What's NOT Allowed

- PC is not a solution for running out of time. You cannot use
   PC to drive to parking if you've run out of hours.
- Rush hour traffic, poor planning, or delays do not qualify for PC use.

 PC is only allowed when you're off-duty and relieved of all work responsibilities.

### When PC is Allowed

- Driving from a truck stop to a restaurant or hotel while off-duty
- Commuting from your home to the terminal (if not on the clock)
- Traveling to a nearby safe location **after unloading**, if you're off-duty

### Adverse Driving Conditions Exception

If you run into unexpected conditions like:

- A closed highway
- A sudden weather event
- An accident blocking the road

You can use the **Adverse Driving Conditions Exception** to extend your driving time **by up to 2 hours**. But this only applies if:

- The condition was not known or reasonably expected before starting the trip
- You use the "Take Exception" function in your ELD to document it

**Rush hour traffic or known delays do not qualify.** Use this exception only when truly necessary and document it clearly.

# Fall Prep: Get Your Truck Winter-Ready While the Weather's Still Nice

The weather is cooling, so while it is still nice, it is a great time to look over your truck.

- Check for rubs or cracks on your airlines. Are they ready for winter temps?
- Glad hand rubbers easier to change now than in the cold.
- Wipers are they ready for winter?
- Bunk filters good air flow = better comfort.

- Tires tread depth, sidewalls, pressure. As temps lower, so will the cold PSI pressure.
- Extension cord is it free of cuts or cracks and in working order?
- Winter front much easier to unfold and inspect now vs in the cold.

Also, as you switch out summer gear for winter gear, leave space for Power Service and a spare box of DEF. We don't need it now, but soon. We have it in stock at Plover and the office for those who like to plan ahead. And as always, we are here for you.

Submitting your paperwork **as soon as you're empty** is more important than ever. This should be a **quick process**—you can fill out most of it while being unloaded, and once you're empty, it should take **no more than 2 minutes** to snap your photos and submit.

Delays in paperwork are becoming a bigger issue, especially with brokers. Many now expect BOLs at the time of loading and within an hour of delivery. Because of this, our previous 24-hour policy is changing: paperwork must now be submitted within 2 hours of delivery.

If you prefer, you can now use **Samsara** to submit your **Proof of Delivery (POD)**:

- 1. Go to **Documents** in the Samsara app
- 2. Tap Create New Document



- 3. Select Proof of Delivery
- 4. Fill out the fields and submit

### **CDL Renewal & Endorsement Tips**

A quick reminder as we head into fall: **several drivers have licenses expiring next month**. When you renew your CDL, consider adding a **tanker endorsement**. Some of you already have it, and it can really help when we're looking for reloads—especially during fall when farm chemicals are moving. There's a small fee, but no test, fingerprinting, or extra steps required.

Also, there's been a **recent change** to how your **DOT physical** links to your license. Medical examiners now upload your results directly to

FMCSA, which then forwards them to your state's licensing agency. That means you no longer need to submit your medical card to the state yourself.

However, you still need to **complete the self-certification process** with your state. And during the transition period (through October 12), you can use your paper medical card for up to 15 days if needed.
